

# Trinity Unit Camping

The following tables are divided into developed campgrounds, boat access campgrounds, day use areas, group campgrounds, and dispersed or remote campgrounds. Developed Campground maximum capacity for single units: 1 vehicle and 8 people.


Double units: 2 vehicles and 12 people. Additional vehicles, if space allows, will be charged \$10.00 per night.


Campsites must be occupied the first night and cannot be unoccupied for more than 24 hours. The "Saving" of campsites is not permitted. Checkout time for family campgrounds is 2:00 pm. Checkout time for group campgrounds is 12:00 noon.


Boat Launch Use Fee: Bowerman, Clark Springs, Fairview, Minersville, Stuart Fork and Pine Cove \$10.00/day

# Group Campgrounds

## Fawn Group Campground

Open May 1 to September 30. Has two separate loops with **maximum** capacity of 100 people per loop. Can accommodate three separate groups or one large group of up to 500 people. **Minimum** capacity is 25 people for one loop, 75 people for two loops.

**Location:** On Highway 3, fourteen miles north of Weaverville, and sixteen miles south of Trinity Center.

**General:** Situated in a moderate to heavy stand of Douglas-fir, pine and oak, all loops offer ample shade. Loops B & C offer direct access to the lake. No developed beach. Fawn is the most popular group site on Trinity Lake. Reservations should be made early as the most desirable dates are filled quickly.

**Fee:** \$140 per night

### Amenities...

- 60 individual campsites each with stove, table and parking spur.
- Flush toilets and drinking water.
- Located right on the lake near full-service marina.
- Loops B and C have group areas with barbecue, fire ring and tables.
- Loops B and C are secluded and quiet.

## Stoney Creek Group Campground

Open May 1 to September 30. Maximum capacity 50 people. There is no minimum capacity.

**Location:** On Highway 3, thirteen miles north of Weaverville and fifteen miles south of Trinity Center.

**General:** This campground does not sit right on the shores of Trinity Lake. It is across the highway from the lake on Stoney Creek. Located in an open stand of fir and pine, this facility has been popular with groups that include children. The open timber stand allows for good visibility. The creek swimming area, although colder than the lake, makes it easier than a lakeshore beach for monitoring children. There are no individual parking spurs. There is a central parking area with tent-only camp units within easy walking distance.

**Fee:** \$120 per night

### Amenities...

- Flush toilets and drinking water.
- 10 individual tent-only camp units each with a stove and table.
- Paved parking lot for up to 20 automobiles.
- Swimming beach along a dammed up stream.
- Central picnic area with barbecue and tables.

## East Weaver Campground

Open May 1 to September 30. Maximum capacity 80 people.

**Location:** From Weaverville, take Hwy 3 north for 2 miles. Turn left on Road 228. Campground is 1.5 miles on left.

**General:** Located in the Weaverville area at the end of East Weaver Road, on the banks of East Weaver Creek, this is a rustic campground with plenty of trees. It is primarily a tent campground but small trailers can fit in 30% of the spurs. The road is paved and the spurs are dirt. Each campsite has a table and a stove/grill. Fuel, groceries, bait and restaurants can be found 1.5 miles away in Weaverville.

**Fee:** \$110 per night

### Amenities...

- Drinking Water and vault toilets
- 10 sites, picnic tables, fire rings
- Parking
- Located in the Weaverville area

### Campground regulations

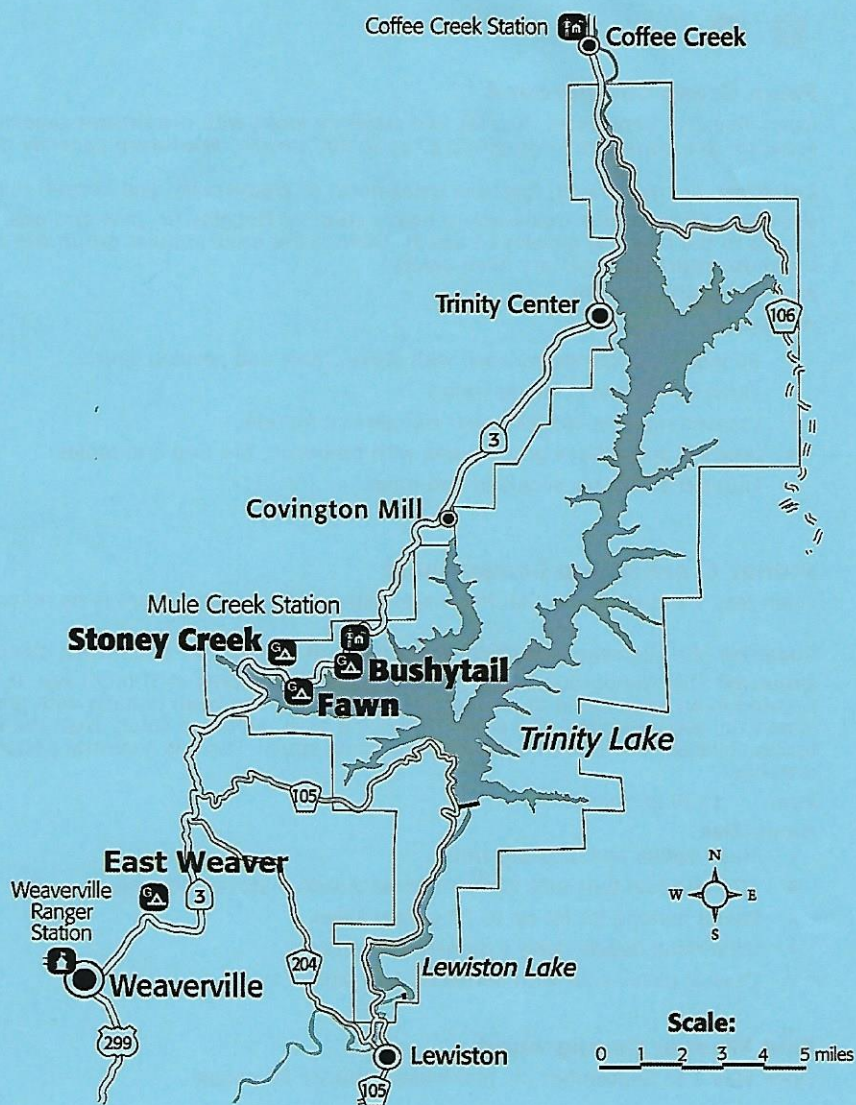
Regulations governing the occupancy of National Forest campgrounds are posted on the information board in each campground. The group leader is responsible for the behavior of all group members and should make sure all are familiar with these regulations. Free maps are available to those not familiar with the Trinity Lake area and may be obtained at the Weaverville Ranger Station. Groups may post their name at the entrance to each campground. Fawn Group Campground has a welcome sign which will have each group's name posted on the scheduled arrival date. To keep un-authorized persons from entering the group site, users are encouraged to keep the gate closed. Any problems should be reported to Shasta Recreation Company at 530-275-8113. For emergencies, call the Trinity County Sheriff's Office at 911.

### Bears

Bears do frequent the area. Please use bear proof garbage bins and food lockers provided. Store your food in airtight containers. Keep food preparation and eating area well separated from your sleeping area.
